Statement to the Market

Diagnósticos da América S.A. is hereby informing its shareholders, holders of debt securities and to the market in general that the Company does not operate derivatives or similar instruments which do not target a minimum protection of its exposure to other currencies, under a conservative policy of not assuming operations that could compromise its financial position.

On May 21, 2008, the Company has finalized the capture of US 250 million for financing its expansion for the next years. The resources of this capture are totally invested in debt securities of short term of the Government of the United States (T-Bills) and are under the custody of Unibanco, headquartered in New York. The operational cash balance in Brazilian Reals are invested in private bills of first class Brazilian Banks and Brazilian Government bills.

Due to the fact that the Company has its revenues denominated in reais and to avoid a possible exposure of the interests to the exchange rate variation during the period of 5 years, when there is not the possibility of a debt pre-payment, the Company has contracted swap operations of the interests at 103.6% of CDI.

The Company does not invest in derivatives or other risk assets or liabilities of speculative nature.
